- No promotion of the company or product is allowed outside of the designated booth area.
- During the hours when the booth area is open, we kindly request that promotional staff with name badges be present at your booth. Individuals without name badges will be asked to leave the Congress Center.
- Audio-visual equipment may be used for promotion within the booth area. However, we kindly request that the volume of the sound does not interfere with other booths or the overall flow and order of the event.
- Bringing food or beverages from outside the Congress Center and distributing them, whether for free or for a fee, is prohibited. For any refreshments you plan to provide at your booth, please contact **opteamist tourism**.

- The fees specified in the sponsorship file and budgets are exclusive of VAT; official VAT rates will be added to booth, accommodation, transfer, sponsorship, and various other fees.
- In accordance with the Turkish Ministry of Finance's Tax Procedure Law (V.U.K.), any changes in the tax rates or additional tax liabilities mentioned in the budget will be reflected at the same rate.
- In case of force majeure events such as epidemics, wars, terrorism, civil unrest, etc. (regardless of whether officially declared), if the congress is postponed or if the format (physical/online) is changed, all payments made to opteamist tourism for the congress will remain valid for the new date and will not be refunded to the company. opteamist tourism reserves the right to increase the prices of services requested by the company due to reasons such as exchange rate fluctuations and inflation as a result of the date postponement.
- The organization rate is the effective selling rate of the Central Bank of the Republic of Turkey on the day of hotel check-in.
- In the case that congress advance payments are made in foreign currency, the amount paid as an advance will be deducted from the total foreign currency amount in the budget for the services to be received. During the final invoicing, advance payments and the remaining balance will be invoiced based on the "Organization Rate."
- If the balances are paid in Turkish Lira (TRY), the amount will be held in the congress account. For the final invoice to be issued after the congress, the total budget amount in foreign currency will be converted into Turkish Lira using the Organization Rate. A Turkish Lira invoice will be issued, and the remaining exchange rate difference will be collected.
- Participants and sponsoring companies agree that the amounts collected before the congress will be considered as an advance payment, and they accept that any differences arising from exchange rate increases will be reflected.
- All invoicing will be done after the congress has concluded.



FINANCIAL TERMS AND CONDITIONS
